Annual Crime and Fire Safety Report Based on data from Calendar Year 2021

Prepared in compliance with the 'Jeanne Clery Disclosure of Campus Security Policy and Campus Crime Statistics Act' and the 'Higher Education Opportunity Act'





Introduction:

AVTEC is committed to providing a safe environment to allow our students to participate in training programs which support the economic growth and stability of the Alaskan economy. To this end, policies, procedures, and staffing are maintained to take every reasonable step to ensure the safety and security of individuals and property in and around the various AVTEC training, Residence Life, and administrative facilities. No matter how effective these actions are, however, all members of the campus community need to remain vigilant and aware of their surroundings while taking common sense measures to ensure their personal safety. This report is created, in part, to make members of the AVTEC campus community aware of crimes that have taken place on or around the AVTEC campuses during the previous calendar year, so that reasonable precautions can be taken to ensure the well-being of AVTEC students, staff, and the greater campus community.

AVTEC is an adult post-secondary technical training center located in Seward, Alaska. During the reporting year 2022 (January 1 – December 31, 2021), AVTEC maintained 4 'Clery Act' campuses, (Residence Life, First Lake Facility, Applied Technologies, and Port Avenue). All of these AVTEC campuses are located within the boundaries of the City of Seward, Alaska. At the Residence Life Campus, AVTEC supports two Residence Halls with a capacity of 158 individual students and three Student Housing Apartment buildings with a capacity of 19 students and their families. During the training year, the average student population at the Seward campuses is approximately 150 students (varying with the dates and enrollment of short term classes). AVTEC also maintains an unstaffed building, the AVTEC Maritime Safety Training Facility, which is used for training purposes but not included in this report due to Clery Act geographic definition requirements.

During the calendar years 2020-1, AVTEC, along with the rest of the world, experienced an unprecedented and drastic change from usual operations as a result of the Coronavirus pandemic. In-Person classes were pre-empted in mid-March of 2020 and almost all students returned to their home communities where they completed training for that term using distance-learning technology. In-Person training resumed in August 2020 for the fall training term and the mid-year start in January 2021 with lowered student numbers and other strict strategies to mitigate impacts to students related to the COVID-19 pandemic. Training resumed at full capacity in August 2021 with a mitigation plan approved by the Administration of AVTEC and the leadership of the State of Alaska Department of Labor and Workforce Development. This report covers all geographic areas and dates related to AVTEC for the calendar year 2021.

Law Enforcement:

AVTEC does not maintain any campus law enforcement services or employees. Law enforcement on all AVTEC Campuses is provided by the City of Seward Police Department. The Alaska State Troopers have concurrent jurisdiction over certain crimes within the Seward city limits but have not taken any role in criminal investigations related to AVTEC campuses since at least CY2015. The only AVTEC campus that is open and supported by staff during non-business hours is the Residence Life Campus, where all of AVTEC's student housing is located. Overnight staff on this campus have no law enforcement certifications or responsibilities, but maintain a close professional relationship with the Seward Police Department.

AVTEC staff are not charged with enforcing federal, state, or local laws. Staff members who suspect or have knowledge of a violation of law will report the potential violation to the Seward Police Department which has jurisdiction over all geographic campus boundaries.

Annual Report of Campus Crime Statistics:

The Jeanne Clery Disclosure of Campus Security Policy and Campus Crime Statistics Act requires that a report be produced and made available on an annual basis for release to current and potential students as well as members of the greater campus community. Under the Clery Act, only data related to certain criminal offenses is required to be collected. These crimes are Murder/Non-Negligent Manslaughter, Sex Offenses (including Rape, Fondling, Incest, and Statutory Rape), Robbery, Aggravated Assault, Burglary, Motor Vehicle Theft, and Arson. Additionally, if any of the above crimes or any other crime involving Larceny/Theft, Simple Assault, Intimidation, or Destruction/Vandalism is classified as a hate crime (using updated categories from the most recent HEA / Clery Act legislation) it will be included in the report. Arrests or referrals for campus disciplinary action related to illegal weapons possession or violation of drug and alcohol laws will also be included in the report, but only those incidents that would be considered criminal and not those in which an individual only violated a campus policy. Data related to Violence Against Women Act crimes (including incidents of Domestic Violence, Dating Violence, and Stalking) are also included.

In accordance with the Clery Act, crimes that are committed on AVTEC property or on public property immediately adjacent to AVTEC property are included in these statistics when geographic location can be determined with assistance from the Seward Police Department. To facilitate better understanding of the statistics, data is reported for each of AVTEC's four campuses discretely. For this year's report, the Seward Police Department has provided statistical data for crimes reported on and around the various AVTEC campuses. Data in this report was also compiled by AVTEC Staff following policies and procedures related to reporting as set by the Clery Act. Because most of the personal data used to generate reports by both AVTEC staff and the Seward Police Department are confidential, these data sets may or may not overlap, so the statistics provided by the Seward Police Department are provided separately from the statistics accumulated by AVTEC staff.

In accordance with the Clery act, the AVTEC Annual Safety and Security Report with statistics for the 2021 calendar year is published on the AVTEC website no later than October 1st, 2022. The report is also made available at the AVTEC Business Office at 809 2nd Avenue in Seward. A report will be mailed by USPS or electronically via email upon request by contacting the admissions office at 1-800-478-5389.

Timely Warnings and Campus Community Notification:

In compliance with the Higher Education Opportunity Act, AVTEC has created a communications plan in order to provide students, staff, the campus community and members of the public with notification in the event of emergencies, threats, or alerts requiring the warning of others in the area. This communications system involves a variety of methods of spreading information about a threat to the community, including a campus-based intranet system, campus email and telephone systems, public electronic bulletin boards, megaphones, signage, word of mouth and public bulletin boards. AVTEC staff also utilize various social messaging platforms and an opt-in text messaging system to electronically notify members of the campus community in the event of an emergency.

In the event of a situation that warrants notifying the campus community to practice different levels of caution, evacuation, or other actions, a member of the AVTEC Administration or a Department Head will notify the campus community in a timely fashion of crimes or other incidents on or around campus that require action on the part of members of the campus community. The campus community will be immediately notified when a significant emergency, situation, or serious threat of harm is present to students or staff, so long as this notification does not compromise staff or law enforcement activities to contain the incident.

Timely Warnings will be issued to the campus community in the event of a situation affecting an AVTEC facility that in the judgment of a member of the AVTEC Administration or a Department Head constitutes a threat to the student body or wider campus community. Depending on the campus involved and the type of incident, the Timely Warning can be made by using voice announcements, electronic devices, social media, the campus telephone system, email, social media, or posted notices.

How To Respond To A Crime In Progress:

- Do not attempt to arrest or stop a crime in progress except in cases of self-defense.
- If you observe a crime, please take note of as many details as possible. Number of suspects, description of suspects (clothing, age, height, color of skin, sex, hair, facial hair, direction of travel, weapons involved, car description, license plate, etc.).
- Call 911 and give the dispatcher your name and physical location. If it is safe, wait at the location until police arrive. If it is not safe, tell the dispatcher where the police can find you.
- If you are the victim of a crime,
 - o Do as the perpetrator asks. Do not resist except in cases of self-defense.
 - o Wait until the perpetrator leaves before calling for help.
 - Attempt to get a good description of the perpetrator. Write down the description as soon as possible.
 - o Secure the crime scene and ask other witnesses to remain until the police arrive.
- In the event of an emergency, continue as much as possible with your usual activities. If the incident is taking place outside, avoid doors and windows.
- Do not interfere with individuals making a disturbance or with law enforcement personnel.
- If you are not involved in the incident but are unsure what to do Shelter In Place where you are and call 911. Remain where you are until being given the 'All Clear' by law enforcement.
- After notifying 911, if it is safe, contact the Residence Life 24 Hour Cellphone (907-362-1645) to report the incident.

How To Report A Crime:

Community members, students, faculty, staff, and visitors are encouraged to report all crimes and public safety related incidents that occur in or around AVTEC facilities to the Seward Police Department or AVTEC staff member in a timely manner. Prompt reporting of all crimes that occur in or around AVTEC facilities will assure accurate Timely Warning notices on-campus and correct disclosure of crime statistics. Any on-duty AVTEC staff member can help a victim access the 911 or non-emergency police resources to make a report at any time of the day or night.

Victims or witnesses to a crime who do not want to pursue action with the criminal justice system should still make a confidential report of the incident for reporting purposes. An AVTEC Counselor can file a report with the details of most incidents without revealing the identity of the reporter upon a specific request for anonymity. The purpose of a confidential report is to comply with a crime reporter's wish to keep the matter confidential, while taking steps to ensure the future safety of the campus community. With such information, AVTEC can keep an accurate record of the number of criminal incidents on and around campus, determine where there is a pattern of crime with regard to a particular location, method, or assailant,

and alert the campus community to the potential dangers. Reports filed in this manner are counted and disclosed in the annual crimes statistics for the institution – located at the end of this report.

Crimes that take place in Seward should be reported to the Seward Police Department (911 or 224-3338). AVTEC Counselors encourage students, when appropriate, to report crimes on a confidential basis for inclusion in the annual crime statistics if they are unwilling to report them to the criminal justice system.

AVTEC encourages all campus personnel to report any criminal or suspicious activity and emergencies to the local Police Department as well as to the Residence Life Office. Prompt reporting will ensure Timely Warning notices on campus and the accurate disclosure of crime statistics. AVTEC maintains a professional working relationship with the Seward Police Department as well as the Alaska State Troopers, and will refer all non-confidentially reported crimes and related incidents to law enforcement.

Campus Security Services:

All AVTEC facilities are within the jurisdiction of the Seward Police Department which is responsible for law enforcement on and around all campus properties

Many AVTEC staff members are trained in CPR and First Aid and can provide initial medical attention to individuals in need in or around AVTEC facilities. AED's (Automated External Defibrillators) and first aid kits that include Narcan for response to opioid overdose are available at several locations around several AVTEC campuses. Some AVTEC staff are trained in Mental Health First Aid and crisis de-escalation techniques to assist students experiencing mental health emergencies access appropriate resources.

When necessary and appropriate, AVTEC staff members will arrange for transportation using either AVTEC vehicles or the Seward Volunteer Ambulance Corps to allow injured or ill students, staff, or facility users to access advanced medical care available at the 24 hour Emergency Room in Seward.

Access to Campus Facilities:

The AVTEC Business Office, Administration Office, and Academic Department Offices are open to students and the public during business hours (typically 8AM-5PM Monday-Friday).

During non-business hours, access to all non-Residence Life areas of AVTEC campuses is restricted to staff only.

Academic training areas are open during business hours to students, invited guests, and escorted visitors with prior permission from the responsible Department Head or member of the AVTEC Administration. Visitors to hazardous areas or student labs are required to wear personal protective equipment necessary in those areas. **As a result of the Coronavirus Pandemic, during CY2021, visitors to any AVTEC facility were required to complete a health screening form prior to entry.

Residence Halls are open to residents and escorted guests over the age of 18 from 7AM-10PM daily and to residents only from 10PM-7AM daily. Unescorted or overnight guests are not permitted in the Residence Halls at any time. **As a result of the Coronavirus Pandemic, during the Spring and Fall 2021 training terms, non-student visitors were not permitted into Residence Life facilities at any time, and offPage 5

campus/student apartment residents were only permitted into common spaces of the campus, not into individual private Residence Hall rooms.

Student Housing Apartments are open to residents and their guests 24 hours a day. Overnight guests in Family Student Housing are permitted but required to have prior permission from the Residence Life Office. Overnight guests in Student Housing Apartments are permitted for a maximum of 7 nights.

Residence Halls are secured and access restricted to only staff during summer and winter training breaks when training is not in session and the buildings should be vacant.

The first floor of the Student Service Center is open to the public during posted business hours of the Seward Department of Parks and Recreation. Depending on their use of the facility, members of the public may have to pay an access fee to use the facility. The second floor of the Student Service Center is open to the public during special events and was accessible to participants in the AVTEC Adult Basic Education program during business hours until that program ceased operations in May 2021. The entire Student Service Center is open to Residence Hall residents 24 hours a day and to students living off campus or in Family Student Housing from 7AM-10PM daily. Certain facilities inside the Student Service Center may have other restrictions which are posted (e.g. private offices, sauna, library). **As a result of the Coronavirus Pandemic, during the Spring and Fall 2021 training terms, the Student Service Center was open to only current students and staff. Visitors were not permitted in the facility at any time and the Seward Parks and Recreation Department did not operate out of this facility during CY2021.

Emergencies, holidays, and special events may necessitate changes or alterations to posted schedules. Any changes to traditional schedules are posted at building entrances and around campus. **As a result of the Coronavirus Pandemic, access to all campus facilities has been highly restricted during CY2021.

Residence Life and Student Housing:

During the time period covered in this report, the Residence Life Department was staffed 24 hours a day / 7 days a week when students were present in the Residence Halls. Residence Life Attendants are the primary staff persons responsible for providing assistance to residents on all campuses during non-business hours. Residence Life Attendants serve as a resource for residents, enforce campus rules and policies, help to mediate personal conflicts, respond to emergencies, and make reports of incidents on campus to the AVTEC administration. Residence Life Attendants make regular rounds of the entire Residence Life Campus and are responsible for the day to day operation of the Residence Halls, Student Housing Apartments, and Student Service Center. **As a result of the Coronavirus Pandemic, during the Spring 2021 training term, the Residence Life Department was not staffed in the overnight hours (1:00 AM – 6:00 AM) Tuesday-Friday. During times when the department was not staffed, an on-call staff member was available on campus to respond to emergencies and assist residents.

Guest Policy:

Guests in the Residence Halls must be over the age of 18 and escorted by a Residence Rall resident at all times. Unescorted guests are asked to leave. Under no circumstances are non-residents permitted to remain in a Residence Hall room overnight.

Guests are permitted in and around Residence Halls during non-quiet hours (7AM – 10PM). Violating a roommate's right of entry or hindering a resident's ability to study, sleep, or bathe or to their right of personal space are considered violations of the guest privileges. Residents are responsible for the actions and activities of their escorted guests in and around the Residence Halls, as discussed in the Student Handbook. **As a result of the Coronavirus Pandemic, during CY2021, non-student visitors were not permitted into private student rooms at any time and off campus students were only permitted into common areas of the facility.

Overnight guests are permitted in Student Housing Apartments with prior permission from the Residence Life Department Head. The behavior of guests in Family Student Housing is the responsibility of the student-resident. Overnight guests are permitted with prior notification for a maximum of 7 nights.

Missing Student Procedure:

Members of the campus community who suspect that a student is missing for more than 24 hours or may be in imminent danger should report their concern to their instructor, a counselor, or a Residence Life Attendant. Each student is encouraged to list a confidential contact person to be notified in case the student is determined to be missing. Only authorized campus officials and law enforcement personnel will have access to this contact.

In the event a student is reported missing, local law enforcement will be contacted even if the student lists a confidential contact. Students under 18 years of age and missing will have their parent or guardian contacted by a campus representative.

A Residence Life Attendant may enter a student's on campus living area without prior notice to attempt to locate a missing student.

Student Housing Contact:

The Residence Life Office is located at 516 3rd Avenue (Willard E. Dunham Residence Hall) Room 103. Residence Life staff can be reached 24 hours a day at 224-6100 or 362-1645.

Security Aspects Of Maintenance:

All of the AVTEC Campuses are well lit and improvements in lighting and mitigation of safety hazards are made on an ongoing basis around the campuses. Areas that are revealed as problematic by students, faculty, staff, or members of the public will have security surveys conducted of them. Administrators, the AK DOT-PF Maintenance Foreman, and the Residence Life Department Head will review these results. These surveys examine security issues such as landscaping, locks, alarms, lighting, and communications. Additionally, the AK DOT-PF Maintenance Foreman, AVTEC Administration, and all of the Department Heads meet regularly to discuss security and safety issues of pressing concern.

Crime Prevention Efforts:

Throughout the training year, actions are taken to best ensure the safety and security of the campus community. During the large group orientation sessions in August and January, as well as at other class orientation sessions and special events, students are provided with information related to personal safety and housing security and informed of related services offered on campus as well as in the community. Students are informed about crime patterns on campus and in surrounding neighborhoods. Crime and sexual assault prevention programs are offered on an as-needed basis as well as at the annual community health fair. All students are made aware of ways to speak with a counselor on a confidential basis regarding crime and personal issues.

A common theme of all awareness and crime prevention programs is to encourage students and employees to be aware of their responsibility for their own security and the security of others. This includes reminders to lock their doors and windows, use caution in dark parking lots or while walking alone at night, and to avoid keeping or displaying large amounts of cash, jewelry, or valuables on their person and in their personal spaces as well as maintaining a general awareness of their surroundings at all times.

When time is of the essence, information related to crime prevention and personal safety is released to the AVTEC community through Timely Warnings and security alert notices posted throughout campus, via email, intranet, public video displays, and SMS Text messaging, as well as by word of mouth from staff.

Alcohol Policies:

AVTEC actively enforces a zero tolerance policy for the possession or use of alcoholic beverages anywhere on AVTEC property. Individuals in violation of this policy are subject to sanctions including housing restrictions, eviction from student housing, and dismissal from training, at the discretion of the Administration.

AVTEC makes immediate notification to the local Police Department at any point in time staff is made aware that an individual under the age of 21 possesses or has used alcoholic beverages. Individuals under 21 who possess or use alcohol or are found to be intoxicated on AVTEC property are subject to criminal prosecution as well as disciplinary sanctions including housing restrictions, eviction from student housing and dismissal from training, at the direction of the Administration.

AVTEC makes immediate notification to the local Police Department at any point in time staff are made aware that a student over the age of 21 is found to have provided alcoholic beverages to another individual under the age of 21. Any student providing alcohol to minors will be subject to criminal prosecution as well as disciplinary sanctions including eviction from student housing and dismissal from training, at the discretion of the Administration.

Any student found on campus intoxicated under the influence of alcohol will be subject to disciplinary sanctions including housing restrictions, eviction from student housing, and dismissal from training, at the direction of the Administration. Intoxication is determined by behavior and objective signs (i.e. smell of alcohol) Refusal to submit to staff questions after being informed that staff suspects intoxication will be considered a violation of the alcohol policy and treated as if the student involved was objectively intoxicated.

Illegal Drug Policies:

All AVTEC campuses are designated as 'Drug-Free' and the possession, use, manufacture, or sale of illegal drugs (including cannabis) is prohibited. There is zero-tolerance for violation of this policy. For purposes of clarification, illegal drugs are considered to be street drugs (including cannabis) and prescription medications being used without a prescription. This policy differs from Alaska State Law which permits the possession of cannabis and related products in private housing facilities.

AVTEC will make immediate notification to the local Police Department at any point in time when staff is made aware that a student is using, possessing, selling, or manufacturing illegal drugs. Any student in violation of this policy will be subject to criminal prosecution as well as disciplinary actions including housing restriction, eviction from student housing, and dismissal from training, at the discretion of the

Administration. Since Alaska state law allows the personal use and possession of cannabis by individuals over 21 in their personal housing, but AVTEC policy restricts its usage and possession on campus, this notification to law enforcement does not apply if residents over the age of 21 and are using the substance otherwise in compliance with Alaska State Law.

AVTEC will make immediate notification to the local Police Department at any point in time when staff believe that a student is under the influence of illegal drugs and presents a danger to themselves or others. Refusal to submit to staff questions and / or a drug test when reasonably requested by staff will be considered a violation of the illegal drug policy. Any student found on campus under the influence of illegal drugs will be subject to disciplinary actions including housing restriction, eviction from student housing, and dismissal from training, at the discretion of the administration.

A student in violation of this policy does not need to be intoxicated by illegal drugs, only under their influence, in possession, or attempting to sell or manufacture illegal drugs, including marijuana on AVTEC campus property.

Substance Abuse Intervention and Education:

It is imperative that persons with alcohol or drug problems obtain professional counseling before arriving at AVTEC. There are limited resources for substance abuse treatment available within the community of Seward. For those students who are actively working to overcome a substance abuse problem, Alcoholics Anonymous and Narcotics Anonymous group meetings are typically available locally on a daily or weekly basis and Residence Life staff will assist students confidentially accessing these resources upon request. AVTEC Counselors are available to provide counseling, support, or assistance connecting those in need with community resources.

Substance abuse support services and referrals for treatment are also available from AVTEC counselors who maintain offices on the Residence Life campus.

Weapons Policy:

The possession, use, or display of weapons is strictly prohibited on all AVTEC campuses. This includes, but is not limited to firearms, ammunition, explosives, knives with blades longer than 3 1/2 inches, switchblades or gravity blades, and other dangerous substances. This policy includes the display of pellet, air, replica, and other toy guns designed to accurately resemble an actual weapon. This policy exempts properly stored and used culinary knives possessed by enrolled Culinary Arts students, as well as culinary knives inside the kitchen areas of Student Housing Apartments. Should you encounter anyone on or around any AVTEC campus in possession of a weapon, please contact the local Police Department immediately by calling 911.

Any person found in violation of this policy may be subject to criminal prosecution as well as student discipline up to and including eviction from campus housing or dismissal from training, at the discretion of the administration.

Gambling Policy:

In accordance with the laws of the State of Alaska, gambling without an explicit permit from the State of Alaska Department of Revenue is strictly prohibited on any AVTEC campus. This includes raffles, lotteries, sports betting, and card games for money. Gambling with a permit from the State of Alaska Department of Revenue may not occur without explicit written permission from the AVTEC Director or their designee.

Sex Offender Registration:

The State of Alaska maintains an online database of individuals convicted of sex offenses in Alaska since January 1st, 1999. Individuals can search this database by geographic region or by name. This database is available at https://sor.dps.alaska.gov/Registry/Search. This website address is published in the student handbook and made available by AVTEC Counselors upon request.

AVTEC staff will work with law enforcement personnel as requested to ensure that all members of the campus community who are required to be in this registry are compliant with the law.

Sex Offenses:

As an educational institution, it is a priority for AVTEC to provide an environment conducive to honor basic civil rights of all members of the community. To this end, the following sexual offenses are prohibited, will be considered serious infractions of student conduct, and will be thoroughly investigated when reported. Individuals found to have committed a sexual offense will face campus sanctions up to and including dismissal from training or eviction from student housing as well as charges through the criminal justice system. Dating violence, domestic violence, sexual assault (including rape, fondling, incest, and statutory rape) and stalking of any student or campus community member on or around AVTEC property is not tolerated by AVTEC and every accusation related to any of these offenses will be treated seriously by all AVTEC staff members. All AVTEC Staff and long term students will participate in a mandatory Title IX training on an annual basis.

When a student makes an accusation against another student of a sexual offense, immediate steps will be taken to provide safety and security to all students. Reasonable protective measures will be implemented as soon as possible, including but not limited to the moving of the accused or accuser to a different housing location, the provision of a Leave of Absence for the accused or the accuser, and the temporary restriction of the accused individual from certain activities or areas of the campus.

Students who make an accusation against another student of a sexual offense will be made aware, through a meeting with their counselor as well as in writing, of their rights during the discipline process, including the right to anonymity and to not involve the criminal justice system, the availability of changes to their academic, housing, transportation and working situations, and the right to be present with an advisor for any and all judicial or disciplinary hearings throughout the process, regardless of the involvement of the criminal justice system. They will also be informed in writing, of resources available to them, including physical

health, mental health, victim advocacy, and legal assistance both from AVTEC and other community resources.

In the event any AVTEC employee is made aware of a sex offense committed in or around an AVTEC facility or upon an AVTEC student, that employee should take the following actions

- 1. Ensure that the victim is safe. If there is imminent danger call 911.
- 2. Encourage the victim to obtain necessary medical treatment at the emergency room. If necessary, staff will arrange for ambulance transportation or provide transportation to the emergency room in an AVTEC vehicle.
- 3. Encourage the victim to preserve evidence of the offense. Avoid taking a shower or washing clothing that was worn during the offense
- 4. Contact the AVTEC Student Services Department to start the process of responding to the incident. If the Title IX coordinator or one of the Counselors cannot be contacted, then the staff person should contact the Residence Life Attendant on duty. With permission from the victim of the incident, the staff person should also notify the local police department of the incident and provide details. While it is not required that the local police become involved in the situation (unless a child or vulnerable adult is involved) victims should be encouraged to report any and all sexual offenses to the criminal justice system.

In the event that the victim decides to not report the crime to law enforcement, the AVTEC Title IX Coordinator or Counselor shall document the incident for the purpose of including it in the annual crime statistics report. With permission from the victim, the AVTEC staff person will help the victim to confidentially notify a local DVSA program for assistance in reporting the crime and obtaining treatment and other resources for the victim.

5. Notify the victim that AVTEC will change their academic or living situation, and make other reasonable accommodations after an alleged sex offense if those changes are requested by the victim.

Any AVTEC staff interacting with a victim of a sex offense should encourage the victim to confidentially speak with an AVTEC counselor, Title IX Coordinator, or a representative of a local DVSA program, and to report the crime to the local police department. Staff should also offer to assist the student in making this report to the police and inform the student about what services are available through other community resources. Most AVTEC staff are required to notify the Title IX Coordinator when they become aware of any sex offense on campus or involving a student.

Individuals who are a victim of a sexual offense are encouraged to seek assistance from a Domestic Violence / Sexual Assault program in their area. Programs are available in Seward (Seward Prevention Coalition DVSA Program – 362-1843-24 hours or Seaview Community Services Crisis Line 224-3027-24 hours).

Daily Security Log:

The Residence Life Department Head maintains a daily crime log for all four AVTEC campuses in Seward. This log documents all Clery Act reportable crimes in and around AVTEC facilities and is available to the public and can be viewed at the Residence Life Office upon request.

Fire Log:

The Residence Life Department Head maintains a daily fire log for all four AVTEC campuses in Seward. This log documents all reportable fires in and around AVTEC facilities and is available to the public and can be viewed at the Residence Life Office at 516 3rd Avenue, room 103, Seward.

Student Conduct and Discipline:

All AVTEC students are expected to comply with the policies and procedures published in the AVTEC Student Handbook which is provided to all students at orientation. Information about student conduct, grievance procedures, and disciplinary sanctions are available in the handbook as well as on the AVTEC website at www.avtec.edu.

Other Reportable Offenses and Incidents:

Hate Crimes:

The Clery Act requires the collection of specific data from events that are reportable under the Clery Act as well as any other crime involving bodily injury that manifests evidence that the victim was intentionally selected because of the perpetrators bias. The recognized categories of bias include race, gender, religion, sexual orientation, ethnicity, national origin, and disability.

During the calendar years 2008 - 2021 (Clery Act reporting years 2009 - 2022) there were no incidents that manifested evidence of a hate crime in or around any of the AVTEC campuses.

Fires:

During the calendar years 2020 - 2021 (Clery Act reporting years 2021 - 2022) there were no incidents of fires on any AVTEC campuses in Seward.

AVTEC Annual Fire Safety Report

Summary: a.

AVTEC maintains a fire safe campus by identifying and eliminating potential fire hazards through annual and ongoing inspections and emphasizing compliance with all fire and building codes. Additionally all fire protection systems are inspected, maintained, and tested regularly under the supervision of the DOT-PF Facility Maintenance Foreman and the City of Seward Fire Chief and Building Official.

b. **Student Housing:**

All Residence Halls are equipped with monitored fire and smoke alarms and fire suppression systems. In the event of alarm, the Seward Fire Department will be notified by the alarm monitoring company and will respond. All AVTEC Residence Halls and apartment buildings meet current fire protection codes. Fire and smoke alarms and sprinkler systems are inspected annually by certified inspectors.

All Student Housing Apartments are equipped with hard wired and battery operated smoke detectors. One Student Apartment building with a common entrance is remotely monitored by an alarm monitoring company.

Fire Safety Education and Training: c.

At new student orientation, all students are informed of building evacuation procedures, emergency gathering points and shelters in the community. Students are also informed of fire suppression equipment and locations of alarm pull stations. Fire alarm 'drills' are not required or performed on the AVTEC campuses.

Students are provided with fire safety instruction and training at the annual community health fair typically held in the Student Service Center. Additional training is provided on a class by class basis for training programs where fire safety is part of the recognized curriculum.

Prohibited Items d.

Residents of Residence Halls are not permitted to have in their room any cooking device which creates heat (e.g. hotplates, bread makers, cook tops) or microwave ovens. Residents of Student Housing Apartments are permitted to utilize any residential type electronic cooking appliance inside their apartment as well as charcoal or propane fired barbecues in the parking areas but not on the deck outside their apartment.

Items that have an open flame (e.g. candles, incense, tea lights) are prohibited inside all student Residence Halls but are permitted inside Student Housing Apartments.

Other types of items that are prohibited in or around on-campus housing facilities include but are not limited to:

- i. Dangerous / hazardous chemicals
- ii. Modified electrical devices with exposed wiring
- iii. Gasoline, fuel, lighter fluid, or camping fuel
- iv. Automobile or commercial batteries

 - v. Used car or truck parts
 - vi. Other items deemed unsafe by AVTEC Administration, Residence Life Staff or the Seward Fire Department.

Smoking Policies e.

All AVTEC facilities, entrances and vehicles are smoke free in accordance with State of Alaska Law. Smoking is permitted only in designated areas. Individuals in violation of this policy may face campus discipline as well as criminal prosecution. 'Smokeless' E-Cigarettes are considered smoking devices and may only be used in designated smoking areas.

Fire Evacuation Procedures f.

- 1. As part of the orientation process, as soon as residents arrive on campus they are encouraged to learn the location of emergency exits and fire alarm pull stations closest to their housing assignment.
- 2. If a resident smells smoke or discovers a fire, they should sound the facility fire alarm by activating a pull station. DO NOT attempt to fight a fire due to the hazards associated with the products of combustion and the threat of spreading fire.
- 3. When the fire alarm sounds, all residents and guests must leave the building AT ONCE. Use the nearest safe exit. Upon exiting the building, go to the designated assembly point at the student lounge in the Student Service Center. Do not attempt to re-enter the building until told it is safe to do so by Residence Life or Fire Department Staff.
- 4. DO NOT use the elevator for evacuation
- 5. Feel the door for heat before leaving any room while an alarm is sounding.
- 6. If the door is hot or smoke is seeping in, DO NOT open it. If you become trapped and can not reach an exit, keep the door closed and seal off any cracks. Use a phone to call 911 and give the exact location of the room. If you do not have a phone go to the window and signal from the inside using a pillowcase or sheet. DO NOT JUMP. The Fire Department will assist you.
- 7. If the door is cool, open it cautiously. Be braced to quickly slam it shut if the hall is full of smoke or if you feel pressure or heat upon opening the door. If the hall is clear, proceed to the nearest fire exit.
- 8. If caught in smoke or heat, stay low where air should be clearer, take short breaths through your nose until you reach a safe exit or place of refuge.
- 9. Fire Doors are designed to close when the fire alarm sounds in order to prevent the spread of noxious gasses or fire in an emergency situation. If a resident discovers a problem with one of these doors or any other aspect of the Fire Alarm System (pull stations, smoke detectors, fire extinguishers, etc.), inform a Residence Life Staff member immediately.
- 10. Residents who need special accommodations to be alerted to fire alarms (visual cues, etc.) or special assistance to evacuate the building should inform a Residence Life Staff member as soon as they arrive on campus.

Reporting of fires: g.

All fires in or around AVTEC facilities must be reported to the AVTEC Department Head responsible for the facility in question. The Department Head is responsible for notifying the AVTEC administration as well as the Residence Life Department Head for the purpose of reporting the fire in the annual Fire Safety Report.

j. Improvements:

There are no improvements currently scheduled or underway to any of the fire safety alarms or devices on the Residence Life Campus.

k. Statistics / Fire Log:

During the calendar years 2008 - 2018 and 2020 - 2021, there were no reportable fires in any of the student housing facilities on campus.

In CY2019 there was one incident of attempted arson to a common area of a student housing apartment building. This incident caused minimal damage and was unsuccessful in staring a fire. Evidence of this incident was observed after the individual responsible was evicted from the housing assignment for non-related reasons.

All fires that occur in student housing areas are recorded in a fire log that is kept in the office of the Residence Life Department Head and is available for viewing during regular business hours. Events in this log are published in the annual fire safety report.
